Similarly with Long Rd West/East the fact that th road is straight appears to give drivers permission to travel way beyond the speed limit. Some time ago the 30mph flashing signs were placed at both ends Ardleigh Rd with virtually no impact upon the speeds being travelled. I worry that if traffic calming measures are introduced on Long Road in isolation (i.e. without being replicated on Ardleigh Road), the volume of traffic could in fact increase. For example, motorists coming from Lawford will avoid Long Road and divert via Ardleigh then speed down Ardleigh Road to access the A12. The problem needs to be considered in the round, and something really needs to be done.

There was a mobile speed camera in operation yesterday, and the difference in road noise in our back garden was noticeable. That has spurred me to contact you about this matter.

In addition when you consider the number of footpaths along this stretch which attract a number of pedestrians and dog walkers it is now frankly ridiculous not to consider making this section of the road safer. During term time school buses also use this part of the road to drop off children whom live in the surrounding houses.

Perhaps you might consider some of the following proposals to make this stretch of road safer.

1. An automated speed limit sign that measures the speed of cars as it passes the higher density housing.

2. A reduction of the speed limit from 40mph to 30mph perhaps in conjunction with above.

3. No overtaking lines in the road.

4. Rumble strips along parts of Long Road West to remind drivers of the limits.

Traffic Dangers along Long Road West,

Dedham

We believe you are already aware that our near neighbour Gary Neville of Barn Cottage suffered a broken arm when he was struck by a car outside his home on Tuesday 16th June. It was only a matter of time before this happened and we thank God he was not killed or more seriously injured.

We were aware that Dedham Parish Council had been pressing the Highway department of Essex County Council for the current 40mph speed limit to be reduced to 30mph and we supported this. However, we gather this issue remains unresolved after a long period of time so felt we should make you aware of our daily experiences of using the road as pedestrians so you may seek to progress matters before a fatality occurs.

We have lived in our home within the 40mph of Long Road West for nearly 30 years. During this entire period we have always owned two dogs which we have walked a few hundred yards along Long Road West to the nearest Public Footpath , before and after work:

Road Useage – obviously there has been some respite during the "Lockdown", but we have seen a tremendous increase in the number of vehicles using Long Road West - from 5am until late evening. It has become a "rat run" for residents of Manningtree and Lawford and beyond accessing the A12 and perhaps now using the Football Stadium access to the Town Centre to avoid the queues on the A120, Ipswich and Harwich Roads into Town.

The Vehicles using the road- the cars are all bigger and wider than in the past . Wing mirrors can extend a foot or more beyond the side of the cars or vans.

The Road – as the name suggests, it runs from East to West, so drivers are facing the sun in their eyes in the mornings and evenings. The road is no longer wide enough to provide a safe haven for pedestrians (which include school children who catch the School buses at the end of Long Road West) when two modern cars pass and do not stop or slow for them.

The Drivers – everyone is in a hurry and very few pay attention to pedestrians or the existing 40mph speed limit.

Many may be unaware of the limit because most of the signs have rusted at their base and been removed by Highways and never replaced. It is a long straight road and in the early 1900s was used for Motor Cycle racing; many still use it to "test " the limits of their cars today.

Near misses (or accidents waiting to happen) – one of us will walk with the dogs in the bottom of the ditch at the road side because there is not room for you and two dogs on the verge. Perhaps just once per month a driver will slow if a vehicle is coming in the opposite direction, mostly the drivers just keep coming and do not reduce speed, leaving us to jump back to avoid wing mirrors. Near misses are a daily occurrence.

On one occasion Amanda was "clipped" by a mirror, spinning her around. On two occasions in the last month alone when speeding vehicles have failed to slow for us and a vehicle is passing us in the

| As you've probably already heard, we had another nasty traffic incident in Long Road West earlier this week, when one of my neighbours was struck by a car and suffered a broken arm. It is all too easy to imagine an even worse scenario involving a horse and rider, or heaven forbid, a child in a pram or push chair. | |
| Our Dedham Speedwatch group regularly operate in Long Road West (although not during the Covid lockdown) and we like to think that our | |

activities go some way to help slow traffic, and perhaps make drivers more alert. Nonetheless, it is obvious to everyone in the group that only when our activities are supplemented with police action that drivers moderate their behaviour. I think that this view is shared by the police, but of late they seem far more reluctant to put resources into this field. This is most frustrating, and has been raised on numerous occasions with the appropriate figures within the force, but to no avail.

As you know, "TruCam" (a tripod mounted speed camera, on the basis of which a ticket can be issued) is being rolled out across Essex, and is, I think, now available in Colchester. I suspect that our position at the periphery of the county raises logistical problems, but half-promises to operate the equipment periodically within Dedham, with a Community Support Officer, have so far come to nought. So, in other words, police support has, so far as I am aware, been "nil". (Interestingly, Langham are lucky enough to have a resident "special constable" who operates frequent speed traps outside his home, and I believe this has led to a speed reduction within the village.)

Personally, I've never been convinced that lowering the 40-mph limit to 30 mph is a panacea so far as Long Road West is concerned. Enforcement of the existing limits would be a good start, as would be a full set of post-born repeater roundels on the verges, coupled with speed roundels painted on road surface.

I personally think that would be great for the centre of Dedham - stretching along the high street, Forge street, Mill Lane upto the river, etc. Cars at 30mph is just too fast for a high street that has residents, lots of parked cars (and so people coming out from between them), and tourists. On Bargate Lane itself - it's great to see that the 30mph signs have recently been put up on the side coming from Harwich Rd however, especially at rush hour, this doesn't deter people, just using Bargate Lane and Long Rd as a thoroughfare to get to the A12, from racing along at well above 30mph I do genuinely believe that speed bumps on Bargate Lane, given the houses that are there, wouldn't go amiss. | We have two young children (age 1 and 3), and find walking along this stretch of road with the pushchair particularly frightening. It is a real shame as we moved here to be close to the countryside and the many walks in the vicinity of the house. Our property is directly on the road - we have no fencing across the front of our driveway. It is a daily occurrence to see pedestrians jumping onto our drive to take shelter from the speeding traffic. As soon as we are able to, we will fence across the driveway to make it safe for our own children - unfortunately this will make passage even more dangerous for others as they will no longer be able to wait on our drive. I worry that if traffic calming measures are introduced on Long Road in isolation (i.e. without being replicated on Ardleigh Road), the volume of traffic could in fact increase. For example, motorists coming from Lawford will avoid Long Road and divert via Ardleigh then speed down Ardleigh Road to access the A12. The problem needs to be considered in the round, and something really needs to be done. | Speed is a continuing and growing problem. In particular there is a 'boy racer' who drives pass most nights in the early hours making as much noise as he can - he can be heard for some considerable time as he approaches passes and continues all at high speed. Pot holes are a danger -we have watched the one on Long Road West grow over the months. How someone could claim that it was not bad enough is a puzzle. If you know its there it can usually be avoided but if two cars meet that causes a problem - now worse as there is damage on the other side. Holes at the side of roads are also dangerous - Long Road, Coggeshall Road and Bargate Lane. A particular problem is that so often repairs are poorly carried out. Some repairs only last a short time. A particular traffic management problem is Bargate Lane. The sides of the road are being eroded and there is a danger that cars cannot avoid deep potholes if they move to the side. This is particularly so when the holes are water filled. Again previous repairs have been poorly carried out. It is common to meet 10 or more cars along the lane it being used increasingly as a short cut from the main road. We wish you good luck. Action is sorely needed. |

| I completely agree with your concerns about traffic management here in Dedham, in particular with the confusion caused by speed limit changes - Grove Hill & Long Road West are prime examples where there are relatively short sections (maybe half a mile-ish long) with limits increased to 40mph, giving through traffic the impression that they can speed up, only then having to fall back to 30mph. The result is that on re-entering the 30mph zones, they are still exceeding the speed limit when approaching junctions such as with Grove Hill/Stratford Road (especially as the limit change is so close to the junction) and LRW/Coggeshall Road As you know, I live at the bottom of Grove Hill, by the S-bends, and am in a 40mph zone. With the significant increase in traffic over the last 25+ years I have been here, there has been a corresponding proportion of inconsiderate drivers who ignore the speed limit altogether and see the S- bends as something like a rally challenge prompting corner-cutting especially. | There are of course consequences here - a national speed limit applies along Birchwood road and with the signage removed/obscured there is every reason for cars to approach the Birchwood chicane too quickly and then to continue high speed driving as they exit Birchwood road at Lamb Corner. The speed of cars and bikes racing past our house is astonishing. Given relatively limited visibility from the drives it can only be a matter of time before a very serious accident occurs. The removal of the signs means that the speed limit is unenforceable - any competent lawyer could argue that the speed limits were not displayed according to the law - so speeders, if they get caught, face no penalty. For more clarity I attach some photos below. The 30mph signs entering Lamb Corner have both been damaged. In fact the 30mph sign had been removed physically from both sides of the road. I have managed to temporarily rehang one (on the nearside as you enter the lamb corner chicane) but the other is beyond repair. Please see the photos below - you can see where the sign has literally | causing a power cut. If authorities say they have no record then that is not true. There may even be court records too as the driver left the scene and we believe was later found. Evidence is out there it just needs finding.
